Prior to Racing:

V Dartnell, trainer of **HOWARDIAN HILLS** in the second race, requested permission for the horse to go down to post early.

A Corson, trainer of **LITTLE LOTTIE** in the fifth race, requested permission for the horse to parade once around the paddock and go out to the course.

Permission was granted to both requests.

The Chief Steward gave permission for **MOLLIANA** to be mounted in the shute or on the course.

Race 1 - 2.30pm. THE LA VERTE RUE ASSOCIATES HANDICAP HURDLE

No enquiry

BORN LEGEND, pulled up, the rider reported that the horse was not suited by the distance.

A Malzard, trainer of **FOURNI**, was asked to explain the improvement of the horse over hurdles. The trainer reported that the horse had finished second on the flat in her previous race and was carrying bottom weight.

Race 2 - 3.05pm - THE BRADY & GALLAGHER (1999) HANDICAP

No enquiry

The Stewards interviewed Ms. P Bridgwater about the performance of **FRIVOLOUS PRINCE** in the closing stages of the race as the Stewards noted that the horse had needed a couple of reminders. The rider reported that in her opinion the horse needed to wear Blinkers next time out.

Race 3 - 3.40pm. THE MILLBROOK 2019 JERSEY BULLET HANDICAP

No enquiry

The Chief Steward ordered the routine testing of the winner **FRUIT SALAD**, trained by Mr. K Kukk.

Race 4 - 4.15pm. THE GEOFFREY EDWARDS MEMORIAL HANDICAP

No enquiry

The start was delayed whilst Mrs. C Gilbert, trainer of **BROWN VELVET**, changed the horse's girth. The Stewards interviewed the trainer after the race who advised that in future she will double check all equipment. The Chief Steward instructed the Head of Racing to write to all trainers to remind them of their responsibilities.

Race 5 - 4.50pm. THE GREEN VALLEY HANDICAP

No enquiry

The rider Mr. Gary Mahon, declared to ride three horses for the trainer Mr. K Kukk did not arrive on the course. The Stewards have suspended Mr. Mahon in absentia for 7 days pursuant to rule D24.1. This suspension will come into force subject to the Head of Racing of the CIHA ascertaining that there are no mitigating factors.
