#### **Permissions**

Prior to racing CELINE DE LA HAYE trainer of **COOL DANDY** requested that the horse have a handler at the start. The Stewards granted this request.

Prior to racing CELINE DE LA HAYE trainer of **COUNTESS CIARA** requested that the horse wears a red hood, goes straight to start and has a handler. The Stewards granted this request.

Prior to racing ALYSON MALZARD trainer of **MAQUIGNON** requested that the horse go down to the start last from the parade ring. The Stewards granted this request.

All requests were duly granted.



# RACE 1 - 2.30pm A Handicap Hurdle about TWO MILES & ONE FURLONG

### RACE 2 – 3.05pm A Handicap about SEVEN FURLONGS

The stewards enquired into a false start having reviewed the footage – no offences under rules were discovered and no further action was taken.

The starter confirmed that **COOL DANDY & BANK ON KENT** did not come under starters orders after refusing to pull up after the false start and completing a circuit; they were withdrawn.

The Doctor confirmed that both jockeys of **COOL DANDY**, Laura Coughlan & **BANK ON KENT**, Tom Buckley were fit to continue riding.

Both Jockeys were interviewed after the race. Laura Coughlan rider of **COOL DANDY**, reported after her horses false start the horse was slowing and she was confident of a return to the start but was then reinvigorated by **BANK ON KENT** passing making it impossible for her to pull her mount up. Tom Buckly rider of **BANK ON KENT**, reported the horse bolted, one of his feet came out of the irons and he was unable to pull his mount up - latterly trying to pull up he was unseated by his mount.

The Stewards were informed that **CASARUAN** started 10lb over the advertised weight.

The Stewards were informed that **BANK ON KENT** started 1lb over the advertised weight.

## RACE 3 – 3.40pm (off 3.55pm) A Conditions Stakes about ONE MILE & HALF

The stewards were notified from a representative of Celine De La Haye about their dissatisfaction with the perceived delay waiting for **MAQUIGNON** ridden by Fred Tett to arrive at the start. The complaint was noted by the stewards.

The stewards called an enquiry of possible interference in the closing stages between **CUEROS & MAQUIGNON**. The stand side camera showed a possible clash between the pair but after examining the head on footage it was decided no significant interference had taken place. The stewards were satisfied that it did not affect the places and that no riding offences had occurred.
